Cancellation, Refund Policy, Terms and Conditions

Introduction

This document outlines the policies and terms for Investor Relations training masterclasses ("the Event") organized by F.I.N.E.O GmbH ("FINEO Investor Relations Advisors"), a company incorporated in Switzerland (registration number CHE-273.540.954, registered office at Tribschenstrasse 62a, 6005 Lucerne, Switzerland).

Registration and Payment

- Registration is complete upon submission of a duly completed and signed Event Registration form and full payment.
- Tickets are issued to named participants only and are non-transferable without prior written approval from FINEO.
- Prices are subject to change at FINEO's discretion.
- Full payment must be received by May 22, 2025. FINEO reserves the right to cancel bookings, deny entry, or offer spots to waitlisted participants if payment is not received on time.

Cancellation and Refund Policy

- Submit written cancellation notice to info@fineo.com.
- Cancellations and refunds are processed as follows:
 - More than two months prior: 50% refund
 - Between two months and one month prior: 25% refund
 - o After May 22, 2025: No refund, liable for the full registration fee
- This policy applies to all circumstances, including COVID-19 related reasons, such as transportation disruptions, border closures, visa issues, illness, travel advisories, quarantines, or death.
- FINEO retains the right to refund registration fees and decline event registration at its discretion, without incurring liabilities or penalties. Approved refunds will be issued within 30 days to the participant's original payment method.
- Transfer of registration to a different participant at no additional charge is discretionary and subject to timely written notification.

Event Changes and Cancellations
